

# Planned Burning in the Haddon, Smythesdale & Linton Area

Midlands District – Autumn 2017

## A number of planned burns have been programmed in the Haddon, Smythesdale and Linton area this Autumn.


Each year, Forest Fire Management Victoria (FFMVic), together with CFA and other emergency services, carry out a fuel management program in Victoria's parks and forests to reduce the bushfire risk to communities, property and the environment.

FFMVic will only ignite a planned burn when fuel moisture and weather conditions, such as humidity, temperature and wind speed have been assessed as suitable. The decision to proceed is made on the day of the burn following extensive monitoring of these conditions.

Enfield – Incolls East	4km NW of Enfield	717ha
Enfield – Oroughlins Rd	2km SE of Enfield	279ha
Enfield – Parkinsons Rd	5km NE of Enfield	112ha
Haddon – Haddon Common	1km E of Haddon	45ha
Linton – Happy Valley 3	3km SE of Linton	113ha
Smythesdale – Bushland Reserve	3km NW of Smythesdale	13ha
Smythesdale – Hillcrest Rd	2km WNW of Smythesdale	319ha
Rokewood – Illabarook Grasslands	10km NW of Rokewood	11ha



**Please Note:** These are the burns that will be targeted during Autumn 2017 when conditions are suitable. As the season progresses other planned burns on the Fire Operations Plan (FOP) may be programmed, please refer to the Planned Burn Notification System or the DELWP website for the full FOP.

# Planned Burning in the Haddon, Smythesdale & Linton Area

## Forest Fire Management Victoria (FFMVic) and Fuel Management Program

FFMVic consists of specialist staff drawn from the Department of Environment, Land, Water & Planning, Parks Victoria and VicForests. FFMVic is responsible for planning and implementing the fuel management program throughout Victoria's parks and forests.

The fuel management program includes planned burning, which involves the planned use of fire under carefully managed conditions to reduce fine fuel, such as undergrowth, dead wood, leaf litter, bark and shrubs. Burns are carried out near communities and in remote areas to help reduce the spread and intensity of bushfires and the threat to life and property. Planned burns also help plants and animals that have evolved to depend on fire to survive.

The planned burns programmed for completion form part of a broader fuel management program planned for the Midlands District. Planned burns are prioritised using a risk-based approach to bushfire management according to a number of criteria including; protection to life and property, community requirements, environmental considerations and geographic distribution across the landscape.

## Protect your health from smoke

Fuel management programs are happening across Victoria to reduce bushfire risk to communities and the environment. Smoke may affect some people's health; asthma or other lung or heart conditions, older people and young children are particularly at risk.

### If you live in or are visiting a smoke affected area, plan ahead to protect your health:

- Keep checking when and where planned burns are expected to happen in your region so you can be prepared for smoke. Plans can change at very short notice because of the weather. Refer to the Planned Burn Notification System (PBNS) and contact the Fuel Management Team on [midlands.fuelmanagement@delwp.vic.gov.au](mailto:midlands.fuelmanagement@delwp.vic.gov.au) or (03) 5335-0716 to have you details added to the individual burn plan.
- If you have a health condition follow the treatment plan provided by your doctor and if you are asthmatic, follow your asthma plan and carry reliever medication with you.

### During smoky conditions:

- First check [www.emergency.vic.gov.au](http://www.emergency.vic.gov.au), if the smoke is caused by a fire, you may be at risk and need to leave. If the smoke is from a planned burn, stay indoors with windows and doors closed.
- You may wish to leave the area if it is affected by smoke.
- If you experience symptoms that may be due to smoke exposure, seek medical advice or call Nurse-on-Call on 1300-606-024.

## Planned Burn Notification System (PBNS)

The Planned Burn Notification System notifies people when a planned burn in a park or forest is close to being ignited. The system provides you with advance notice of upcoming planned burns to make informed decisions about managing the effects.

It displays all FFMVic burns that are intended to be carried out in Victorian parks and forests over the next three years and shows their status.

## Fire Operations Planning

The Fire Operations Plan (FOP) outlines where and when FFMVic intend to carry out fire management operations on Victoria's public land over the next three years. They include planned burning, slashing, mowing and clearing works creating and maintain fuel breaks and carrying out fire infrastructure maintenance.

These plans are driven by our strategic planning and are updated each year with the latest local information to help us work out what fuel management activities to carry out.
